I will only give a Verbatim report to all 11 Parishes I represent including Cosgrove due to the purdah period prior to County Elections 4/5/2017.

NCC: It has been a busy year again this year, what with. The Budget, Devolution and Brexit!!! Former Revenue budget of £1.2B has now been reduced to £840M. Council Tax is 4.95% being the 4th lowest in the Country. £54M invested in a new building for our workforce, closing 12 older building that were not congenial for working purposes. The County Council over next 4 years will split into 5 depts. namely: Transport, Social Care, Children's Services, Communities and Place as well as Finance. All controlled from the Centre by the Cabinet and 57 Councillors who will continue to scrutinise these services and continue to hold 51% of overall control.

Devolution: Has brought its own problems with the 6 Districts + the Borough and County Council, not being able to agree on Unitary Authority status. This will rumble on for some time.

Brexit: Has had no effect on us yet

Locally: I have dealt with MK Master Plan, Traffic Accidents, Public Transport and A508 issues. **Empowering Councillor Donations:** Cosgrove WI for Map; Cosgrove PC towards cost of replacement railings (Main Street / Canal towpath)

Finally: Having been successful in getting Old Stratford Roundabout / congestion into the NCC Transport Strategy have seen £3.5M grant for reconstruction work which will commence late 17 early 18.
